With reference to Communication Cell's e-tender reference no. and subject cited above, it is hereby notified, for information of all concerned, that the Technical Bids of six participating firms, namely, (i) M/s Acoustic Arts Private Limited (ii) M/s Ind-Agiv Commerce Limited (iii) M/s Pragati Engineers (iv) M/s G H Traders (v) M/s Sun Enterprises & (vi) M/s JBR Electronics were evaluated by the duly constituted Technical Evaluation Committee. The TEC has submitted its report dated 09/08/2019, according to which, out of six participating bidders, two firms, namely, M/s Sun Enterprises and M/s JBR Electronics, offering products of two different OEMs, have qualified the technical evaluation criterion and their technical bids are accepted.

2. It is further informed that the financial bids of the technically qualified firms will be opened on 14/08/2019 at 11:00 AM in Committee Room No.134, NITI Bhawan, New Delhi-110001. The representatives of the technically qualified firms, who wish to attend the financial bid opening process may do so bringing along authorization letter from their respective firm. The report of the Technical Evaluation Committee is also attached herewith for ready reference.

**Report of Technical Evaluation Committee**

Sub:-Invitation of online bids towards procurement of a complete Audio Conference/ PA System for Conference Room (Bengal Tiger) on the 5<sup>th</sup> Floor of NITI Bhawan.

Ref:-(i) Communication Cell's Etender Reference No.05/17/2019-CMU dated 01/07/2019 (Tender Id 2018\_NITIA\_482432\_1).

(ii) Communication Cell's O.M. No.05/17/2019-CMU dated 03/07/2019 constituting the TEC-cum-FEC.

With reference to Communication Cell's eTender Reference No.05/17/2019-CMU dated 01/07/2019 (Tender Id 2018\_NITIA\_482432\_1), on the subject cited above, the Technical Evaluation Committee held its first meeting on 07/08/2019 at 11:30 AM in Committee Room No.122. The online technical bids of 6 participating firms, namely, (i) M/s Acoustic Arts Private Limited; (ii) M/s Ind-Agiv Commerce Limited; (iii) M/s Pragati Engineers; (iv) M/s G H Traders; (v) M/s Sun Enterprises & (vi) M/s JBR Electronics were evaluated in accordance with the terms and conditions of the tender document. The report compiled after evaluation of the documents received through CPPP is as follows.



2. M/s G H Traders had failed to submit the Demand Draft towards Earnest money deposit within the stipulated time and and was only submitted to the Bid Opening Committee at the time of opening of the bids. Accordingly, in terms of Clause 11 of the Etender Notice and Clause 7 of the "Instructions to the Bidders" of the tender document, the bid of M/s G H Traders was rejected. M/s Pragati Engineers had not submitted (i) OEM Authorization in accordance with Annexure 5J of the tender document, (ii) Certificate of OEM Vetting the Technical Specifications of the products offered in accordance with Annexure 5K of the tender document and (iii) Technical Specifications of the products to be offered in accordance with Annexure 7 of the tender document. Accordingly, in view of these major deficiencies, the technical bid of M/s Pragati Engineers was also rejected.

3. The technical bids of M/s Sun Enterprises were found to be in meeting all the technical criterion of the tender under reference.

4. While evaluating the technical bids of (i) M/s Acoustic Arts Private Limited, (ii) M/s Ind-Agiv Commerce Limited & (iii) M/s JBR Electronics, the following minor deficiencies were noticed and the committee unanimously decided to seek clarifications from all three bidders:-

5. Accordingly, M/s Acoustic Arts Private Limited, M/s Ind-Agiv Commerce Limited and M/s JBR Electronics were asked to submit the required Revised Annexure 7, duly vetted by the respective OEMs. M/s Acoustic Arts Private Limited and M/s Ind-Agiv Commerce Limited were further asked if they could supply the products offered at Sl.No.1 to 7 of Annexure 7 of the same make. All three bidders were asked to submit their clarifications before 5:30 PM on 08/08/2019.


6. The Technical Evaluation Committee held its second meeting on 09/08/2019 at 12:30 PM in Committee Room No.228. All three bidders submitted their clarifications, which have been attached with the technical bid document at Pages 278-298 and the same were evaluated in accordance with the terms and conditions of the tender document. M/s JBR Electronics successfully submitted the technical specifications duly vetted by the OEM thus meeting all technical qualification criteria (Page 278-280). Both M/s Acoustic Arts Private Limited and M/s Ind-Agiv Commerce Limited submitted the duly vetted technical specifications from the OEM but failed to provide the items listed at Sl.No.1 to 7 of the Annexure 7 of the tender document of the same make (Pages 281-289).


7. The final remarks of the committee upon scrutiny of the documents of all six bidders, as downloaded from CPPP and as obtained through email from the bidders indicated in Para 5 above, are as under

2. In view of the above mentioned remarks, the technical bids of two bidding firms, namely, (i) **M/s Sun Enterprises** and (ii) **M/s JBR Electronics**, offering products of two different OEMs, comply with all the norms of the tender under reference and their technical bids are accepted & hence their financial bids may be opened.
